Prakticum, in collaboration with the Finnish e-sport federation SEUL ry, offers flexible study and training opportunities for athletes aiming at the national and international summit. The training is a privilege for Prakticum students in both Helsinki, Espoo and Porvoo.

The choice for the e-Sports Course takes place after the admission and during the first period. Students may receive training rights, subject to the conditions, even at a later date. Correspondingly, training rights may be deducted if the student fails to meet the requirements or if the training motivation is insufficient. The school's study guide provides additional information about the studies and e-sports profiling.

Agreement

Athletes with e-sports profiling at Prakticum undertake to sign the following contracts:

- Students commit to a sporting lifestyle. Students are taking a healthy diet and adequate sleep. Students aim for their own schedule to provide enough room for training, study and rest.
- Students participate in teaching, if students have not applied for permission or agreed with the subject teacher, there may be absence. If students are illegally absent from the lessons or become in the studies, this leads to a discussion that has consequences for the training opportunities.
- Students with training rights should make progress in their study plan and should behave well and representative of their own and school's best interests.
 Students should be responsible for the school's materials and spaces and comply with the school's general rules.
- When you represent the school on competitions, training, social media or visiting it is school time. The contract also covers such events.
- Drugs and doping do not promote the development of young athletes and do
 not belong to the lifestyle of a goal-oriented sporting athlete. The school reacts
 sharply if students use drugs during school hours or during school trips and
 events. In the event of abuse of the rules, there will be consequences in the
 form of training rights.
- Esport student is required to submit training-, sleep- and diet diaries according to the agreed directives.
